



## **Competition:**

### **Win a share in a racehorse!**

#### Competition Overview

Get your mates together and create a team! You must have a minimum of 4 and a maximum of 10 team members.

Attend as many competition eligible events as you can. EACH team member in attendance will receive ONE (1) entry PER event for their team.

The more team members you have and the more events you all attend, the more chance of winning!

However you will have to share the spoils – a team of 4 will receive a 5% share of the voucher each whereas a team of 10 will receive 2%.

#### Terms and Conditions

##### **General**

1. The Promoter is: Racing and Wagering Western Australia (**RWWA**) of 14 Hasler Rd, Osborne Park, Western Australia, 6017, +61 8 9445 5333, ABN 21 347 055 603;
2. Information on how to enter and prizes forms part of the terms of entry. Entry into the competition is deemed acceptance of these terms and conditions.
3. If there is any inconsistency between these Terms and Conditions and anything else that refers to this competition, these Terms and Conditions will prevail.

##### **Who can enter**

4. Entry is open to all residents of Western Australia over the age of 18 who comply with the conditions set out in paragraph 6 except employees of RWWA, their immediate families and their associated companies and agencies. Immediate family includes the following: spouse, ex-spouse, defacto spouse, child or step child (whether natural or by adoption), parent, step parent, grandparent, step grandparent, uncle, aunt, niece, nephew, brother, sister, step brother, step sister or first cousin.
5. RWWA reserves the right to require that all Team members provide proof of identity, proof of residency at the nominated prize delivery address and/or proof of entry validity or proof of registration ownership in order to claim a prize. Proof of identification, residency and entry considered suitable for verification is at the discretion of RWWA. If each winning Team member cannot provide suitable proof, the winning Team will forfeit the prize in whole and no substitute will be offered.
6. It is a condition of entry that all Team members satisfy Racing Australia's Australian Rules of Racing and racehorse ownership requirements. Each Team member acknowledges that if his or her Team wins the prize, he or she must notify RWWA and the Registrar of Racing Information Services Australia Pty Ltd (**Registrar**) if:
  - during the past 10 years, he or she has been convicted of any offences involving violence against a person or dishonest or criminal activity; or
  - there is a charge pending against him or her for any of the above offences; or
  - he or she has ever been convicted under the Australian Rules of Racing or the rules of any racing authority.

The winning Team's eligibility to claim the prize is subject to the Registrar's approval. If all Team members are not approved by the Registrar, the winning Team will forfeit the prize and the prize will be deemed unclaimed.

##### **How to enter**

7. Details of how to enter the competition are set out on the Own The Dream website ([www.ownthedreamwa.com.au](http://www.ownthedreamwa.com.au)).

8. To enter the competition, entrants must register a 'Team' via the online entry form on [www.ownthedreamwa.com.au](http://www.ownthedreamwa.com.au); each Team must meet the criteria of the following conditions and also comply with the conditions set out in paragraphs 4 and 6:
  - a. each Team must consist of between four (4) Team members and ten (10) Team members;
  - b. each Team must nominate a Team Captain for contact purposes.
  - c. each Team member and Team Captain may only be entered in one (1) Team.
  - d. registration for Teams closes at 11.59pm on Sunday 8 December 2019.
9. Teams will receive one (1) valid entry into the competition for each Team member that attends a competition eligible event as outlined in paragraph 10.
10. The seven (7) competition eligible events include (dates subject to change):
  - a. 17 January 2020 Own the Dream Launch
  - b. 19 January 2020 Southern Stable Tour
  - c. 26 January 2020 Stud Tour and Masterclass
  - d. 2 February 2020 Magic Millions Barrier Draw
  - e. 8 February 2020 Pinjarra Race Day Marquee
  - f. 16 February 2020 Ascot Stable Tour
  - g. 17 February 2020 Own the Dream Finale – Day 1 Magic Millions Perth Yearling Sale
11. To attend a competition eligible event, individual Team members must register their attendance via the online registration form on [www.ownthedreamwa.com.au](http://www.ownthedreamwa.com.au).
12. At least one Team member must attend a minimum of three (3) competition eligible events, in order for the Team to be eligible to win the grand prize.
13. Each Team member must have attended at least two (2) competition eligible events prior to the Pinjarra Race Day Marquee in order to attend this event. The two (2) competition eligible events could be any two of the following; Own the Dream Launch, Southern Stable Tour, Stud Tour and Masterclass and the Magic Millions Barrier Draw.
14. Selected teams are required to select a barrier at the Magic Millions Barrier Draw in which they will be matched with a horse in the Magic Millions 2YO Classic or the Magic Millions 3YO Trophy. Underneath each barrier block is the name of a horse in which will be allocated to that team.
15. Teams must be in attendance at both the Magic Millions Barrier Draw and the Pinjarra Race Day Marquee to claim the prize which will be announced closer to the event.
16. If the winning Team is not in attendance at Pinjarra Race Day Marquee, the prize will be provided to the runner-up Team and so on.
17. Registration to attend each event must be received no later than ten (10) days before each event. It is up to the discretion of RWWA to accept additional team members post this date.
18. Team members must validate their entry at each respective competition eligible event by checking in with a representative of RWWA.
19. Racing Teams have been established for individuals that cannot find a Team but would still like to be part of the competition. Each Racing Team will consist of up to ten (10) members. An individual may express their interest to join a Racing Team, subject to their approval of the T&C's.
20. Each member in the Racing Team must attend at least one (1) event to be eligible to claim the grand prize if their Racing Team is successful. If a member has not attended one (1) event, they will be removed from the Racing Team if their Racing Team wins the grand prize. Racing Team members are still bound by the rules stated as per paragraph 13,14,15,16.
21. If a member leaves the Racing Team, the remaining Racing Team members will receive a higher percentage share if they are successful in winning the grand prize.

## Prize Details

22. Total prize pool value is up to \$AUD 37,500.00 (including GST) as at Monday 17 February 2020.
  - a. First prize is a \$AUD 10,000.000 Magic Millions Voucher which can only be used at the 2020 Magic Millions Perth Yearling Sale towards the purchase of a Racehorse or share in a Racehorse where such horse was sold via auction at the yearling sale. The first prize includes training fees paid for two years to 31 July 2022 (**Period**), unless the Team exercises the option to continue to own that share of the Racehorse on an ongoing bases (as per paragraph 26 described below). The total value of the first prize is \$AUD 30,000.000.
    - i. RWWA will provide the winning voucher direct to Magic Millions for the purchase of the selected yearling. For the avoidance of doubt, no voucher or monies will be provided directly to the winning team with all transactions taking place between RWWA and Magic Millions.
  - b. The first prize must be used on a yearling to the value of \$50,000 or above that is purchased at the 2020 Magic Millions Perth Yearling Sale.
  - c. Training (including spelling and pre-training), bloodstock insurance, WestSpeed fees, race and jockey fees associated with any race in which the Racehorse competes are paid for the first two years (24 months) and will be paid by RWWA directly to the trainer, monthly, when an invoice is received (until 31 July 2022).
  - d. Second prize is a \$AUD 5,000.00 Magic Millions Voucher which must be used at the 2020 Magic Millions Perth Yearling Sale towards the purchase of a Racehorse or share in a Racehorse where such horse was sold via auction at the yearling sale. To redeem the voucher, the Team must purchase the share of a yearling of their choice and provide RWWA with a receipt of purchase for reimbursement up to \$5,000 by 31 March 2020.
  - e. Third prize is a \$AUD 2,500.00 Magic Millions Voucher which must be used at the 2020 Magic Millions Perth Yearling Sale towards the purchase of a Racehorse or share in a Racehorse where such horse was sold via auction at the yearling sale. To redeem the voucher, the Team must purchase the share of a yearling of their choice and provide RWWA with a receipt of purchase for reimbursement up to \$2,500 by 31 March 2020.
23. The first, second and third prize voucher will be drawn via random ballot and announced at the Magic Millions Perth Yearling Sale (Day 1) at 7.00pm WST (or after the final lot is sold) on Monday 17 February 2020.
24. At least one Team member must be present at the Magic Millions Perth Yearling Sale (Day 1) at 5.00pm WST on Monday 17 February 2020, for the Team to be eligible to win the first, second and third Prize.
25. Only one prize can be claimed per Team.
26. Prize values are based upon the recommended retail prices at the time of printing (inclusive of GST). RWWA accepts no responsibility for change in prize value between now and the ultimate prize redemption date.
27. At the end of the Period, the winning Team has the option to either continue ownership of the Racehorse (and will be liable for its share of training fees and other costs and charges that may result) or offer on the open market their share (with value determined by market demand), and will be liable for its share of training fees and other costs and charges that may result until the Racehorse is sold.
28. If the Racehorse is sold before the end of the Period (at the absolute discretion of the winning Team), the winning Team will receive the net proceeds of sale based on the percentage share they own.
29. The stated prize value does not include the prize-winnings component (if any) of the prize or the additional benefits associated with the Racehorse. The prize-winnings component of the prize (if any) depends upon the success of the Racehorse during the Period.
30. RWWA does not provide any warranty or accept any liability in relation to the quality or performance of the Racehorse, the number of races the Racehorse will compete in, the value of prize-winnings the Racehorse will win or the value of any prize. Any decision regarding the health of the Racehorse or the entry of the Racehorse into any race will be at the absolute discretion of the trainer of the Racehorse or the relevant racing authority.
31. The winning Team will not be permitted access to the Racehorse at any time, except as allowed by the trainer or syndicator at their complete discretion at any race meetings in which the Racehorse runs.
32. RWWA is not liable for any loss of potential prize-winnings or earnings if the Racehorse becomes injured, becomes ill or dies during the Period and is unable to race.
33. Independent financial advice must be sought as tax implications may arise as a result of accepting the prize.

34. Prizes cannot be transferred, exchanged or redeemed for cash.
35. It is a condition of accepting the prize that all Team members must comply with all the conditions of use of the prize and the prize supplier's requirements. It is the responsibility of the winning Team to confirm such conditions with the prize supplier or other relevant third parties.

#### **Further Terms & Conditions**

39. Subject to complying with all relevant State legislation, RWWA reserves the right to amend, cancel or suspend this competition if an event beyond the control of RWWA corrupts or affect the administration security, fairness, integrity or proper conduct of the competition. RWWA will disqualify any individual who has tampered with the entry process or any other aspect of this competition.
40. RWWA and its associated agencies and companies assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorised access to, or alteration of entries, and reserves the right to take any action that may be available.
41. If for any reason this competition is not capable of running as planned, including due to infection by computer virus, bugs, tampering, unauthorised intervention, fraud, technical failures or any causes beyond the control of RWWA, which corrupt or affect the administration, security, fairness or integrity or proper conduct of this promotion, RWWA reserves the right in its sole discretion to disqualify any individual who tampers with the entry process, take any action that may be available, and to cancel, terminate, modify or suspend the competition, subject to any direction given under State legislation.

Each entrant hereby assigns to RWWA all right, title and interest in and to all copyright and all moral rights in any material created or otherwise submitted to RWWA in connection with that entrant's entry or participation in any aspect of the prize (**Works**). Each entrant warrants that RWWA is free to use the Works (including modifying, adapting or publishing the entry, whether in original or modified form, in whole or in part or not at all) and to

exercise its rights in relation thereto and neither the entrant nor any third party will be entitled to any fee for such use.

48.
